

Footsteps of Paul Tour to Greece / May 20-31, 2019 / Led by Dr. Dale W. Manor

TOUR TERMS & CONDITIONS

1. DEPOSITS:

Registrations require a signed and dated Kenneth Mills Tour Registration Form and a \$500 deposit per person. **Late registrations** risk airspace not being confirmed.

2. FINAL PAYMENTS:

Final payment must be received by January 10, 2019. Payments received later will be assessed \$250 per person and must be paid by a Cashier's Check or Money Order. If final payment is not received by 90 days prior to departure, the participant's tour space will be canceled and the deposit forfeited.

3. TOUR CANCELLATION:

Written cancellation must be sent directly to Kenneth Mills Tours. Participant must receive confirmation of cancellation.

Cancellations (for any reason whatsoever) are subject to a **\$50 Kenneth Mills Tours administrative fee.**

Canceling 90-120 days prior: \$500 fee

Canceling 50-89 days prior: 50% of tour price assessed

Canceling 0-49 days prior: 100% of tour price assessed

There are no refunds for international tickets once issued!

4. DEPOSITS & FINAL PAYMENTS:

Deposits and Final Payments are payable to **Kenneth Mills Tours.**

5. FINAL DOCUMENTS:

Final tour documents (including airline tickets and any itinerary adjustments) will be available one week before departure to facilitate any last minute changes.

6. AIR TRANSPORTATION:

Airline(s) group economy airfares (10 persons flying the same route) are non-refundable and issued about 40 days prior to departure. Tickets do not permit changes in names, cities, or dates without penalty. Airfares are subject to change until ticketed. Bonus and discount coupons are not applicable. Group economy tickets are not upgradable, and seats are assigned by the airline in a group block. Requests for special seat assignments are not permitted.

7. HOTELS:

Prices are based on 4-star hotel rooms (twin bedded, double occupancy). If changed, similarly priced hotels are used. Single room occupants (for any reason) must pay single room surcharge.

8. MEALS:

Daily breakfasts & dinners. Coffee/tea are only included with breakfasts. Three meals a day are included on the cruise.

9. GROUP TRANSFERS & ENTRANCE FEES:

Overseas group transfers and entrance fees are included. Individual transfers are not included for those who deviate from tour itineraries.

10. GUIDES:

English-speaking guides are provided.

11. PORTERAGE:

Overseas portorage of 1 suitcase is included. The fee for additional suitcases/flight bags is \$1 per hotel for each in/out.

12. LUGGAGE:

Group touring is limited to one normal size suitcase (not to exceed 50 lbs) and one carry-on piece.

13. PASSPORTS & VISAS:

Each participant is responsible for a valid passport with 6 months validity for USA return (effective through November 30, 2019), and must mail or e-mail to Kenneth Mills Tours a legible copy (do not fax). Copy of passport is required at the time of tour registration. A visa is not required on this tour for U.S. passports. Other than U.S. passports must advise Kenneth Mills Tours at the time of registration.

14. NO SMOKING POLICY:

Smoking is not permitted on coaches or flights.

15. ITINERARY CHANGES:

The itinerary has been planned under the direction of your tour leader. It is possible that the daily itinerary may be adjusted by unforeseen circumstances.

16. PRICING FLUCTUATIONS:

Tour prices are based upon current tariffs, agreements and exchange rates in effect at the time of brochure production, August

2018. These factors are outside the control of Kenneth Mills Tours, and will be defined by Kenneth Mills Tours at least 60 days before departure. If the fuel surcharges increase any time prior to ticketing you will be assessed.

Kenneth Mills Tours reserves the right to add a surcharge if the dollar declines more than 2.5% against the Euro based on foreign exchange rates in effect 8/17/2018. (Pricing based on exchange rate of Euro to US Dollars on this date were 1.15). All payments are to be in US Dollars.

17. TRAVEL INSURANCE:

Kenneth Mills Tours strongly recommends the purchase of travel insurance for protection of your tour and luggage investments. Many tour companies recommend Travel Guard. Go to Squaremouth [<https://www.squaremouth.com/>] and compare a number of policies from different companies and make your own decision. Please familiarize yourself with what is available and their requirements. Many companies require you to purchase a policy within "X" number of days of your registering for the tour.

18. TOUR OPERATOR RESPONSIBILITY:

Kenneth Mills Tours, herein and hereafter referred to as KMT, and/or its agents, acts only in the capacity as a broker agent for the passenger in all matters connected with hotel lodging, sightseeing, tours and transportation, whether by air, rail, motor coach, boat, or any other means and as an agent holds itself free of responsibility for any damage or expense resulting from any cause whatsoever. KMT and/or its agents will not be responsible for any damage or expenses or inconvenience caused by late registrations, late airplanes, trains, boats, or changes in any of their schedules due to strikes or any other reason whatsoever. KMT will not be responsible for the loss or damage to luggage or any passenger's personal belongings. KMT recommends the purchase of Travel Insurance to cover such events. KMT reserves the right to refuse any person as a tour member at any time before or during the actual tour. KMT reserves the right to cancel,

change, or withdraw the tour in whole or in part at any time. The sole obligation of KMT is to refund payments received in connection herewith if not acceptable by tour members. Refunds for canceled airfares and services abroad for any reason will be made only after having been received from the airlines, hotels, or companies performing these services, less any out-of-pocket expenses incurred by the operation resulting from those cancellations and will follow the guidelines herein contained for cancellations.

19. AIRLINE RESPONSIBILITY:

The participating airline(s) is responsible only for the air travel portion of this tour performed for it on behalf of tour participants in accordance with the terms and conditions of their individual passage contracts and subject to the applicable laws, treaties and regulations governing air transportation. Tour services, including but not limited to carriage by land or sea, guide services, hotel accommodations, restaurants and all services other than carriage by air, are furnished by contractors who are independent and do not act for or on behalf of the above airline and

the above airline shall not be responsible for any act, omission or event occurring prior to the tour participants embarkation upon or after his/her disembarkation from the aircraft. The usual passage contract by the airline when issued shall constitute the sole contract between the airline and the tour participants and in purchasing a passage contract as part of this tour, the tour participant acknowledges and accepts the foregoing conditions. The above airline is not to be held responsible for any act, omission or event during the time the passengers are not on board its aircraft.

INCLUDED IN PRICE:

1) Round trip airfare from Little Rock, Arkansas [*INCLUDES Carrier additional surcharge Q per passenger 14.25 USD; Carrier-imposed international surcharge YR per passenger 320.00 USD; Taxes per passenger (subject to change at date of ticketing) 147.00 USD*]; 2) Seven (7) overnights in total hotel accommodation based on sharing guest room with private bathroom, in 4-star hotels in Greece, on half board basis (buffet breakfast & dinner); 3) Comprehensive sight-seeing tours/visits with the services of professional local English-speaking government licensed Bible oriented guide as outlined in the itinerary; 4) Entrance fees/tickets to the archaeological, historical sites & museums as specified in the itinerary; 5) English-speaking escorted group transfers between Athens Airport and hotel in Athens and vice versa, transportation by private, fully air-conditioned, deluxe motor-coaches as outlined in the itinerary; 6) English-speaking escorted group transfers between hotel in Athens and the port of Piraeus and vice versa, transportation by private, fully air-conditioned, deluxe motor coaches as outlined in the itinerary; 7) Assistance, portage of one average sized suitcase at hotels and port; 8) Tolls; 9) Third party personal civil liability coverage; 10) Hotel city taxes; 11) Hotel in/out portage; 12) WiFi on the motor-coach on the mainland

portion; 13) WiFi at the hotels (unless it is mentioned as one of the hotel facilities – free of charge for guests); 14) Tips to local tour-guides, motor-coach drivers, escorts, hotel restaurant staff, hotel chambermaids; 15) Hotel service charges, local & municipal taxes, VAT (value added tax).

NOT INCLUDED IN PRICE:

1) All personal expenses such as phone-calls, laundry service, beverages, wines, liquors, tea, coffee, mineral water, food other than the table d'hôte menu; 2) Any other items not specifically mentioned as being included; 3) Lunches on the main land tour; 4) Snacks; 5) Afternoon tea and coffee; 6) Baggage insurance; 7) Excess baggage; 8) WiFi on board the cruise-ship.

INCLUDED IN THE CRUISE PORTION:

1) 3-Day Cruise to the Greek Islands & Turkey, based on an inside (internal) category "IB" air conditioned stateroom, with private bathroom (shower/washbasin/toilet, with body & hand cleansers and shampoo); 2) Full board basis and all-inclusive drinks package aboard ship beginning with lunch on embarkation day and including breakfast on the day of disembarkation; 3) Entertainment on board, free use of shipboard facilities and services of cruise staff; 4) Port taxes, port charges security ; 5) Cruise service charges/gratuities;

6) Mykonos shuttle bus ticket; 7) Tender-boat tickets at Patmos & Santorini; 8) **3 guided shore excursions:** Ancient Ephesus through the ages: Hellenistic & Roman (duration: 3 hours), Patmos: religious visit of the Monastery of St. John the Evangelist & the Cave of the Apocalypse (duration: 2 hours), Heraklion: the Minoan Palace of Knossos, first European civilization (duration: 3,5 hours).

NOT INCLUDED IN CRUISE PORTION:

1) Personal expenses; 2) WiFi on board the cruise-ship; 3) Laundry services (wash, press, dry cleaning), Photos, Casino, Spa treatments, Beauty Parlor, etc.; 4) Santorini one-way cable-car ticket at 6 Euros per person (2018 rate) – you pay on your own in cash at the cable-car ticket booth — **OR** Optional shore excursion in Santorini offered during this cruise: island bus tour to the spectacular village of Oia, perched on the rim of the caldera where you can see the 3 blue domed churches (duration: 3 hours) at 74 Euros or \$91 per person, — **OR** Santorini donkey (or mule) one-way ride up at 6 Euros per person (2018 rate) – you pay on your own in cash there. We strongly recommend not riding the donkeys/mules as it can be dangerous, and if you do so it is at your own risk. 5) Whatever not mentioned as being included.
